

Pierce County Project Access provides access to medical care for people who are low-income and uninsured. We do this with a team of healthcare providers who donate care to those in our program.





You can be a partner with us in this effort! It's easy to become a member of our team.

The cost of serving a patient is \$280 – from application screening to scheduling their first appointment with a provider. Perhaps you feel that's a great place for you to join in our work. #### The New Tax Law on Health Insurance

The tax reform bill that went into effect on January 1, 2018 has received a lot of attention. Everyone wants to know how it will affect them and their healthcare.

The biggest change from the Tax Cuts and Jobs Act of 2017 was an adjustment to the individual mandate requiring Americans to maintain qualified health insurance or pay a penalty. It did not completely do away with the Affordable Care Act's penalty, but instead zeroes out the dollar amount and percentage for those that go without coverage, leaving



the legislation intact for future congresses to make adjustments. However, don't jump for joy just yet. You are still on the hook for 2018. The removal of the penalty will not take effect until 2019.

For large employers with 50+ employees, it is important to note that the new legislation did not do away with the employer mandate to provide coverage or pay a penalty. So, if your employer just started providing coverage due to the enactment of the Affordable Care Act in 2010, then don't expect that to change because of the new legislation.

Lastly, there is a lot of theorist on both sides of the isle trying to forecast how this will affect our healthcare system. In the end, this is a very complex situation and we are all just waiting to see if our crystal ball predictions hold true.

#### **Daylight Savings Time is also Daylight Safety Time**

In most places in the United States, March 11th is Daylight Saving when clocks are moved forward one hour. We here at Pilkey-Hopping & Ekberg want to remind you it's also a great time to improve your family's safety. Health and safety agencies often use the approach of Daylight Saving Time to remind people to change the batteries in their smoke alarms. The American Red Cross suggests you test your smoke alarms and talk with your family about your fire escape plan. It's good to practice the plan too – at least twice a year.

Daylight Saving is a great time to check your emergency preparedness kit to make sure it's fully stocked with fresh supplies. Check out the website <a href="www.ready.gov/build-a-kit">www.ready.gov/build-a-kit</a> for a list of emergency supplies for home and car. And don't forget your pets!

#### Carbon Monoxide a concern too

According to the Centers for Disease Control and Prevention, more than 400 people die annually in the US



from carbon monoxide poisoning. The CDC recommends changing the batteries in your CO detectors when moving your clocks forward. The most common symptoms of carbon monoxide poisoning include headache, dizziness, weakness, nausea, vomiting, chest pain and confusion.
