The Greater Gig Harbor Foundation (GGHF) is the only 501(c)(3) nonprofit community foundation specifically working to meet the needs of our greater Gig Harbor and Key Peninsula communities. Founded in 2006 and dedicated to multifunctional and cross-disciplinary initiatives, GGHF's work includes more than \$7 million in diverse support to help provide parks and needed facilities, protect ecosystems and landscapes on which we depend for clean water and air, economic and public health, the restoration of soul and spirit, and to develop projects and programs for the educational, cultural and social benefit of all.

Recognized in 2017 and 2018 by Living Local Magazine, as the area's "finest" community and philanthropic organization, among GGHF's varied programs are those addressing:

- Food insecurity through its #Community Harvest project. About 2,300 children (1 in 4) in our community struggle with hunger, a figure higher than state (1 in 5) and national averages (1 in 8). In 2018, the program supported essential ingredients for about 12,000 nutritious meals for local families.
- Environmental education and education access and through its *Curious by Nature School* and Stewards Scholarship Fund, which provides assistance to low-income families, giving all children the strong start they deserve.
- Senior population needs through the recently formed *Gig Harbor Senior Center*. With 43.5% of all area residents aged 50⁺ and nearly 28% age 60⁺, the need for a community-based senior center is clear and urgent. Local seniors have no place to gather, interact, learn and thrive!
