A Step Ahead in Pierce County

Mission: To enhance early childhood development and strengthen family relationships, ensuring that every child receives the care and resources they need to thrive.

Providing a Supportive Environment for Families:

A Step Ahead provides home-based therapy and education services for children from birth to age three. They offer specialized support in speech, physical, and occupational therapy, as well as special education.

Beyond therapy, A Step Ahead fosters a supportive environment for families, helping parents and providing guidance through any challenges they may face. Their commitment to inclusivity and accessibility ensures that no child is left behind, regardless of financial barriers.

Programs and Offerings:

A Step Ahead provides home-based services, by providing activities that focus on natural learning opportunities. The philosophy behind these home visits is children learn best in the context of secure and loving relationships. Some of the services provided are as follows:

- **Speech/Language Pathology:** Helps with communication skills to include sign language, vocabulary development, speech production and augmentative communication devices. Also assists in feeding skills.
- **Physical Therapy:** Provides exercises and equipment to help children improve their gross motor skills.
- **Special Instruction:** Specially designed teaching strategies to assist children in developing across all areas of development.
- Occupational Therapy: Assists children in developing daily living skills including feeding, dressing, gross and fine motor development. Also evaluates and treats sensory processing disorders.
- Infant Mental Health: Infant Mental Health Specialists are available to provide relationship-based services for caregivers and their child who is exhibiting social/emotional challenges.
- **Vision Services:** Consultations with Teachers of the Visually Impaired are available for children who have low vision or blindness.




Olympia Harbor Days
